**Ward 11 Update -** Candace - Ward 11 allied voices for equity (WEAVE). Brought a flyer to share.

**CM Koski -** Street sweeping is beginning. Bright pink signs indicate when they'll come. Rent stabilization, next meeting May 2nd, in the midst of information gathering and having meetings. Council has the ability to create an ordinance to put on the ballot. Office of violence prevention was a focus of the ward 11 meeting. Next meeting at May 2nd 7pm at Pearl Park, will be on the environment and sustainability. Presentation on 10 year climate and equity plan, and an opportunity to ask questions, along with a public comments open through May. Neighborhood cleanups on April 22nd for earth day. Koski will stop by ours and Pear Park. Cedar intersection near Fat Lorenzos is in progress. New development going into Chicago and 54th empty lot, high amount of AMI qualifying units. Over 40% are 2br. No studio size units. 47 units. Last night of the 3rd precinct listening sessions, goes till 8:30 tonight, along with an online survey to submit comments. Survey closes April 30th. Hotels near Bachmanns will become 37 units of SRO, plus second lot that will go out for RFP (with restrictions on development). 12th &
